# FINANCIAL DETAILS

## ESTIMATED LAND PACKAGE COSTS

BASED ON LAND VENDOR QUOTES AND CURRENCY EXCHANGE

30 PASSENGERS = \$1728 PER PERSON

## ESTIMATED AIRFARE COSTS

BASED ON HISTORICAL PRECEDENTS FROM IAD TO PEREIRA

30 PASSENGERS = \$750 PER PERSON

## PAYMENT SCHEDULE

BASED ON 30 PASSENGER LAND ONLY QUOTE PRICE (AIRFARE TO BE ADDED ONCE HELD)

OCTOBER 1<sup>ST</sup>, 2021 = \$128 PER PERSON

DECEMBER 1<sup>ST</sup> 2021 = \$400 PER PERSON

# CANCELLATION POLICY

## CANCELLATION DATES

UNTIL 12/01/21 = NO PENALTY

CANCEL AFTER 11/30/21 BUT BEFORE 02/01/22 = \$250.00 PENALTY PER PERSON

CANCEL AFTER 01/31/22 BUT BEFORE 04/01/22 = \$500.00 PENALTY PER PERSON

CANCEL AFTER 03/31/22 BUT BEFORE 05/10/22 = \$750.00 PENALTY PER PERSON

CANCEL AFTER 05/09/22 = NO REFUND

## CANCELLATION PROCESS

ALL CANCELLATIONS MUST BE IN WRITING (EMAIL) AND RECEIVED BY QUEST SPORTS TRAVEL BEFORE THE STATED DATES IN ORDER TO RECEIVE THE APPROPRIATE REFUND. NO EXCEPTIONS. REFUND PAYMENTS ARE MADE AS QUICKLY AS VENDOR REIMBURSEMENTS ALLOW.

PLEASE NOTE, IF YOU PURCHASE TRAVEL INSURANCE WHETHER THROUGH OUR RECOMMENDED PROVIDER TRAVELEX OR INDEPENDENTLY, INSURANCE PREMIUMS ARE ALSO NON REFUNDABLE IN ADDITION TO THE PENALTY AMOUNTS LISTED ABOVE.

# COVID-19 POLICY

WE RECOGNIZE THAT COVID IS A CONCERN AND WILL GO ABOVE AND BEYOND TO ADHERE TO ALL REQUIRED PROTOCOLS TO MAKE THE TOURS AS SAFE AND CAREFUL AS POSSIBLE. OUR CANCELLATION POLICY HAS ALSO BE ADJUSTED TO ALLOW GREATER FLEXIBILITY FOR THE CURRENT UNKNOWNNS WITH THE AIM OR MAKING YOUR TOUR INVESTMENT AS SECURE AS POSSIBLE

THE POLICY HAS BEEN DEVELOPED WITH VENDORS TO EXTEND "NO PENALTY" STAGES AS CLOSE TO DEPARTURE AS POSSIBLE. DATES PUBLISHED IN THE CANCELLATION POLICY ALLOW FULL REFUNDS FOR A FAR GREATER PERIOD OF TIME THAN THEIR PRE-COVID TOURS COUNTERPARTS.

BOTH AIR AND LAND VENDORS DO REQUIRE SOME CANCELLATION FEES ONCE WE GET WITHIN A CERTAIN TIME FROM DEPARTURE. THESE WILL APPLY IN ALL INSTANCES.

IF TRAVEL IS LIMITED BEFORE THE FULL REFUND PERIOD EXPIRES WE WILL DISCUSS WITH THE GROUP WHETHER TO PROCEED OR CANCEL IN TIME TO PROTECT EVERYONE'S DEPOSITS.

AS OCCURRED IN 2020, SHOULD TRAVEL BE LIMITED AFTER THE FULL REFUND DATE PASSES, QUEST SPORTS TRAVEL WILL UTILIZE BEST EFFORTS TO RE-NEGOTIATE THESE CONTRACTS WITH VENDORS. INDUSTRY STANDARD IS TO PROVIDE CREDIT FOR FUTURE TRAVEL IN LIEU OF NON-REFUNDABLE DEPOSITS. THUS, WE ANTICIPATE A CREDIT OPTION SHOULD THE TOUR BE CANCELLED ONCE PASSED THE FULL REFUND DATE.

FORCE MAJEURE - IN THE EVENT QUEST SPORTS TRAVEL IS UNABLE TO PERFORM ITS OBLIGATIONS UNDER THE TERMS OF THIS AGREEMENT BECAUSE OF ACTS OF GOD, PANDEMIC OR OTHER CAUSES REASONABLY BEYOND ITS CONTROL, QUEST SPORTS TRAVEL SHALL NOT BE LIABLE FOR DAMAGES BEYOND THE AMOUNTS AGREED IN THE CANCELLATION POLICY FROM SUCH FAILURE TO PERFORM OR OTHERWISE FROM SUCH CAUSES.
